## **Tulsa Municipal Jail**

- In 2017, the City of Tulsa announced it would open its own municipal jail eliminating the need to send arrestees for city charges to Tulsa County's David L. Moss Justice Center. All surrounding and local communities operate their own municipal lock up facilities as well.
- The City of Tulsa Jail is managed by the Tulsa Police Department and staffed by detention officers from G4S Security. Jail staff consists of 25 detention officers, a G4S security manager and a Tulsa Police Sergeant.
- The City of Tulsa's jail can hold prisoners up to 10 days pursuant to state standards. The facility has 25 male beds and five female beds each divided into their own cell blocks.
- The jail also includes an intake area, holding cells, attorney visitation rooms and separate common areas for males and females.
- Once an individual is detained, they are taken to the Tulsa Municipal Jail to be processed for city charges and/or warrants.
- Municipal or city charges can range from public intoxication, driving with a suspended or revoked license, shoplifting, etc.
- State charges could include first-degree murder, first-degree rape, first-degree robbery and burglary, etc.
- If an individual only has state charges and/or state warrants, they will be taken to Tulsa County's David L. Moss Center, 300 N. Denver Ave.
- If an individual has mixed city and state charges, unless charged with a dangerous state felony, the individual will be taken to the Tulsa Municipal Jail to have city charges processed first before being taken to Tulsa County's David L. Moss Center.
- Tulsa Municipal Judges have an arraignment docket every weekday at 8:30 a.m. immediately followed by a disposition/conference docket.
- Due to the City's generous docket add-on policy, municipal inmates can see a judge any day a docket is available.
- The Okmulgee County Criminal Justice Authority (OCCJA), 315 W. 8<sup>th</sup> St. in Okmulgee, is used for overflow capacity for the jail and for the occasional municipal sentence longer than 10 days.

- Individuals can request copies of arrest records for \$0.25 per page.
